

Christmas Contest

Terms & Conditions

Article 1 - The contest

The “Christmas Contest” is organized by HRD Antwerp nv (Hoveniersstraat 22, 2018 Antwerp, Belgium). In collaboration with Diva Museum (located at Suikerrui 17-19, 2000 Antwerp, Belgium) this contest entails the opportunity to win a certified diamond (provided by HRD Antwerp), Diva Museum entrance tickets, an item from the museum shop and a guided museum tour on condition and in addition to the other conditions set below, that the contestant:

- Follows @hrdantwerp and @divaantwerp on Instagram
- Answers the respective week’s question
- Tags 3 friends in the comment section

Article 2 – Duration

The Christmas Contests first question will be announced on Monday December 3rd 2018 at 9:00 am, contestants have until Friday December 7th 12:00 pm to participate. The second Instagram post will be on Monday December 10th at 9: 00 am, contestants have until Friday December 14th 12:00 pm to participate. The final part of the contest will start Monday December 17th 2018 at 9:00 am, contestants have until Monday December 24th 12: 00 pm to participate. Winners will be announced every Friday in the afternoon between 16.00 – 18.00, except for the final winner who will be announced on Christmas eve 16.00 – 18.00h.

All entries to the Christmas Contest must be submitted no later than the end of the period of the Christmas Contest. Entries received after the end of the duration will not be eligible and will be deemed invalid to participate. No responsibility is accepted for late, lost, delayed or misdirected entries.

Article 3 – Conditions to participate

Entry to the Christmas Contest is free and open to the general public, professional and amateur photographers, excluding HRD Antwerp employees, representatives and/or agents as well as their immediate family (spouse, parents, siblings, and children). Participants should be at least 18 years or older, or, when younger, have acquired the permission to participate from their parents/guardian (hereafter the “Participant”). Participation is limited to one entry per person.

By submitting an entry to the Christmas Contest, Participants warrant that their participation in this Christmas Contest is not illegal or in violation of any law, regulation, treaty or administrative act, and that the laws of their governing jurisdiction of residence at the time of entry do not prohibit or restrict the receipt of any Prize under this Christmas Contest.

Entries will be rejected when they are infringing Belgian law, or the governing jurisdiction of the residence of the contestant. Furthermore, individuals residing in any “Excluded Jurisdiction” are ineligible to enter the Christmas Contest. Excluded Jurisdiction means any country under any kind of economic embargo (e.g. UN-sanctions, US-sanctions, EU-sanctions).

Article 4 – How to participate

For our 2018 Christmas Contest, by entering, you indicate your unconditional agreement to, and acceptance of these entry Terms and Conditions, which are final and binding. Furthermore, you guarantee that all personal information provided to HRD Antwerp is accurate.

To enter the Christmas Contest, the Participant must like the HRD Antwerp and DIVA Museum’s Instagram page, like the post, answer the respective week’s question and tag 3 friends.

Entries are only accepted through the official Instagram app. Participants will not be notified of receipt of their entries. Please note that HRD Antwerp will not respond to inquiries concerning their receipt.

Participants shall bear all costs incurred by entering the Christmas Contest.

HRD Antwerp shall determine entry eligibility in its sole and absolute discretion.

Article 5 – The Prize

The Christmas Contest will have three Prize winners. The third Prize is the one that HRD Antwerp will have to provide and consists out of one certified diamond. Diva Museum will be responsible for the first two prizes as agreed upon, namely 10 duo entrance tickets and an item from the museum shop.

No cash alternative will be offered.

Article 6 – The winners

The winners will be selected by [HRD Antwerp](#) and [Diva museum](#) and publicized on both the Instagrams.

The winners will be announced on our Instagram pages every on Friday 7th and Friday 14th of December between 16.00 – 18.00. The winner of the third week of the contest will be announced on Christmas eve 16.00 – 18.00. If, for any reason whatsoever, the winner is not able to claim the Prize then the Prize will be awarded to the 2nd place.

Article 7 – Personal data & ownership rights

Personal data can be required to:

- Notify winners
- Provide info regarding the Photo Contest and future contest
- Correspond regarding submissions
- Announce winners
- Generate general contest statistics
- Send our questionnaires about the Contest
- Deliver prizes (see also Article 5 above)

HRD Antwerp also reserves the right to, in each and every individual jurisdiction, cancel or suspend the Christmas Contest at any time due to legal restrictions/regulations or because of overriding (self-) regulatory norms, without any right to compensation towards the participants.

Article 9 –Terms and Conditions

By entering the Christmas Contest, the Participant acknowledges having read these Terms and Conditions and agrees to be bound by them and the decisions of HRD Antwerp, which shall be final and binding in all circumstances.

HRD Antwerp reserves the right to modify the content of the Christmas Contest's terms and conditions with retroactive effect should modification be deemed necessary.

Article 10 – Disclaimer

HRD Antwerp does not accept any responsibility for damages arising from or related to circumstances beyond its control, including but not limited to network failure, computer viruses or unauthorized access to its servers. Save where they are due to HRD Antwerp's malice or gross negligence, HRD Antwerp does not accept liability for damages or other harm suffered by Participants as a result of their participation in the contest.

Participants agree to fully indemnify HRD Antwerp and accept all responsibility for any third-party complaints or objections concerning copyright or other intellectual property rights infringement or damages arising from the works submitted.

This Christmas Contest is in no way organized, sponsored, endorsed or administered by, or associated with Instagram. Participants can in no way hold Instagram or HRD Antwerp accountable whatsoever, howsoever.
